One Hundred Seventy-Six Thousand Three Hundred Dollars (\$176,300).

TOWN OF MACHIAS LOAN PROPOSALS PUBLIC WORKS

The Town of Machias is seeking loan bid proposals to purchase vehicles and equipment including three trucks, an excavator, and an accompanying trailer for the following:

Five Hundred Thirty Thousand Dollars (\$530,000), which Machias voters approved at the 2024 Annual Town Meeting.

The Town would like to have two estimates:

3. PUBLIC WORKS USED TRUCK PURCHASE

Public Works Director Mike Schoppee told the Board he has located a used 2016 Western Star truck with 43,000 miles on it, previously belonging to Berwick, and in good condition in part due to being stored indoors. It has been inspected by Freightliner, and the cost is \$77,500.

Mr. Schoppee explained he had included budget for a used truck in this year's town warrant and \$530,000 in spending was approved by voters, to include this truck. Because several other towns were on the waitlist for the truck, Mr. Schoppee requested permission to waive the bid process.

On a motion by Ben Edwards and seconded by Sandra Sinford, the Board VOTED:

To waive the bid process and approve the purchase of a public works truck at a cost of \$77,500.

4. SEWER ABATEMENT 29 WEST STREET

Resident Matthew Barrett requested an abatement of his sewer bill after his basement was flooded by a water heater malfunction. Because the majority of the water went into the ground and not the sewer system, Mr. Barrett asked for an abatement of \$200 on a bill of \$378.88. He has repaired the water heater.

On a motion by Carole Porcher and seconded by Ben Edwards, the Board VOTED:

To abate \$200 off a sewer bill for Matthew Barrett.

As discussed, we can perform explorations at the Machias Town office to investigate if any undermining has occurred from last year's flooding. As I mentioned, I thought it would be useful to break out costs as they can add up quickly out there.

- We can perform 4 exterior borings around the building to depths of about 15 feet or refusal. We can perform the borings and provide a report with geotechnical recommendations for repair, if conditions are warranted. We can perform this scope for a fee of \$9,300.
- We can core the on-grade slab at 4 or 5 locations and advance one shallow test boring using hand equipment. With this method, we are limited on depth but could likely advance to a depth of about 4 to 5 feet. At all the core holes, we would document any void space/thickness below the slab. We would backfill the core holes with concrete. We can perform the interior boring and slab coring, and provide a report with geotechnical recommendations for repair, if conditions are warranted. We can perform this scope for a fee of \$6,300.
- We could just core the on-grade slab at 4 or 5 locations to document any void space/thickness below the slab. We would provide a summary report of the findings. We can perform this scope for a fee of \$2,500.

Alternatively, we could perform all of these services for a fee of \$13,300. For all services (other than just coring the slab), it may be necessary to engage a private utility locator to determine the location of underground utilities. I presume there are underground water and sewer lines below the slab, and we certainly do not want to damage those. I have not carried any cost for this but let me know if you want me to reach out to Bob Briggs. I can put together a formal agreement if this moves forward and once the requested scope is determined.
