Four new development projects, totaling almost \$5 million in new, private investment, are underway as part of the newly adopted Tax Increment Financing (TIF) initiative enacted by voters earlier in the year.

It is wonderful to see so many new projects taking shape throughout the community.

Machias Savings Bank continues to call Machias home, providing many new career opportunities for residents and attracting future residents of all ages. The new facility will allow the bank to create up to fifty new jobs over the next ten years. The building will be named the Machias Savings Bank Operations Center and will house a variety of departments to support the bank's Statewide expansion.

The Sunrise County Economic Council plans to turn the old Nash Building into a Business Entrepreneurial Center focused on small businesses and new start-ups. The Town is pleased that this historic building is expected to be saved and used for a purpose that will continue to grow the Machias economy.

West Falls Holdings LLC purchased the old blue apartment building on the Corner lot of Broadway and Court Street. The apartment building has been demolished and the barn is being rehabilitated to provide commercial rental space.

Justin King has demolished an older home and the old CES Building. It is believed the newly constructed building will house King Construction Services, the CES office, a childcare center, a jeweler, a few modern apartments on the upper level and there is one additional commercial space still available.

The Town has been in conversations with an additional five businesses interested in completing additions or rehabilitations of dilapidated properties. We look forward to assisting all our "Join Us On Main Street" partners in creating a more economically vibrant community for the future.

Dear Citizens of Maine:

For the past eight years as your Governor, my priority has been to make Maine prosperous. I am proud to say that my administration has had some success, but there is more that can be done.

Mainers experienced strong, record-setting economic growth in 2018, setting so many new records: a record-high number of employers; a record-high number of private-sector jobs; record-high revenues for the state; record-low unemployment; and the fastest net-earnings growth in New England. Our poverty rate declined to the lowest since 2005 with the fewest number of children in poverty in 17 years.

Maine's future is the brightest it has been in decades: there's more new businesses, more money in your paycheck, and better opportunities for our children. And that's what it's all about: the future of our state.


We have brought stability to state finances and implemented pro-business, pro-growth policies across state government. The incoming administration is taking on a state government that is vastly improved—both structurally and financially—from the one I inherited. Therefore, I have suggested to the new administration that now is the time to cut taxes by an additional 20 percent.

My administration lowered taxes by 20 percent for more than half-a-million Mainers. Cutting taxes for our families has proven to be an excellent policy decision. Despite this cut, we are seeing higher revenue in almost every tax category—sales and use tax, individual income tax, and corporate income tax. We must always remember that the revenue we receive in taxes is due to the hard work of Maine's people. Democrats stated they want to use surplus money to fully fund revenue sharing at 5 percent, rather than the 2 percent the towns have received for the past 6 years. **However, there is no guarantee your local government will cut your property taxes by one penny—never mind dollar-for-dollar—if revenue sharing is increased.**

The people of Maine and the municipal balance sheets would be better off if the state cut income taxes and allowed municipalities to collect property taxes or service fees from non-profits to supplement the local property taxes. Everyone should contribute to the operation of local community governments.

I encourage you to pay attention to what happens in your municipality and in Augusta. So many good people have worked much too hard to achieve our current prosperity. We must avoid letting politicians drive Maine's finances and its economy back into the ground. I promise you that I will be watching.


As I travel Maine, I hear from people who live in every corner of our state. I hear about their achievements, their successes, their work to improve their communities – I hear about the hope they have for our state. I also hear about our challenges, and all the work we have left to do. As I see it, that's my job: to listen to you, act where I can to build on what's good, and work on the tough parts. As 2018 comes to a close, I wanted to take a moment to share an update on some of the work we're doing in Washington to lift up the accomplishments of Maine people and make progress on the challenges they face.

From Portland to Presque Isle, from Milo to Camden, I hear about the pain that the opioid epidemic is inflicting on Maine communities. I've met with Maine people in recovery, family members of those struggling with substance use disorders, treatment providers, and law enforcement officials to learn about their experiences with this terrible disease, and everyone agrees that in order to fully respond to these problems, we need a stronger federal effort to end the opioid epidemic. Fortunately, some help is on the way – in October, we overwhelmingly passed a sweeping, bipartisan opioids bill. I've pushed hard for this type of legislation and was proud to have provisions I've advocated for included in the bill. These priorities have been guided by the voices of Maine people, and we'll keep working to confront this tragic problem.

I've also worked to strengthen the future of our forest economy. Maine's forests have powered our state's economy for generations, especially in our rural communities. So, when rapid shifts in the market led to the closure of many pulp and paper mills and biomass power plants, it required a collaborative approach to support future growth in this important industry. That's why, together with the other members of the state's Congressional delegation, I pushed to establish the Economic Development Assessment Team (EDAT). This integrated, multiagency effort aims to foster innovation and commercialization in Maine's forest economy, and we're already seeing the benefits: in recent months, several forest industry businesses have announced significant investments into Maine operations, and in September 2018, the Forest Opportunity Roadmap (FOR)/Maine released an action plan to make sure this industry, and the rural communities it supports, can continue to thrive for generations to come.

As I close this letter, please allow me to express my gratitude to each of you – for your dedication to our state, and to one another. It's often said that Maine is like a big small town (with very long streets)—that's because at our heart, we're one big community. It's not only a pleasure to serve you— it's a pleasure to know you. Thank you for being the reason Maine is so special. Mary and I hope that 2019 will be a good year for you, your family, your community, and our great State.

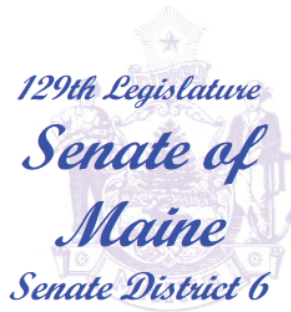

Dear Friends and Neighbors:

First, let me thank you for electing me to represent you in Augusta. I am honored to get to serve you in the Maine Senate. I am eager to get to work so that Maine becomes an even better place to live, work and raise a family.

The 129th Legislature has many issues before it including funding our schools, providing property tax relief, tackling the opioid epidemic, and ensuring affordable access to healthcare regardless of where you live. I hope that others are just as willing as I am to get to work, collaborate, and find solutions for the Maine people.

Ensuring that our schools are funded adequately will be a top priority of mine. Many schools in Washington and Hancock Counties are struggling to provide the supplies necessary for our students to succeed. The lack of adequate funding also puts a burden on property tax payers, many who can't afford an increase. I believe we must combat this by educating our young people regarding the dangers of substance abuse, ensuring our law enforcement officers have the tools they need to stop those trafficking illegal substances, and finally, providing treatment to those that are ready to seek it. Addiction does not discriminate. Folks from every corner of our great state have struggled with it, and we must use every tool in the toolbox to put an end to this health crisis.

Finally, addressing the lack of access to healthcare will be another focus of mine. Folks in Downeast Maine know better than anyone how difficult it can be to find a dentist, eye doctor or physician. Nobody should have to travel over an hour to seek medical treatment. I will work to find ways to increase the number of healthcare professionals here in Maine.

Thank you again for trusting me to represent you in Augusta. I hope the Legislature can come together to tackle the hard issues facing our state, and I am ready to help. Dear Friends and Neighbors,

Thank you all for the opportunity to serve in the 129th Maine Legislature! I consider it a great honor to be able to represent our corner of coastal Washington County in Augusta. Whether that's making the push to reopen Down East Correctional Facility, fighting for our fishermen – particularly those who fish the gray zone – or making the case for restoring revenue sharing (a loss of over \$10 million in property tax relief for Washington County over the past five years alone), I am committed to working with Democrats, Republicans, and Independents to help our rural communities wherever I can.

This year, I am pleased to report that I have been appointed to two legislative committees – Marine Resources and State & Local Government, and have also served as co-chair on the Legislative Caucus on Aging. Each of these responsibilities have kept me on my toes – especially Marine Resources where fishing families are extremely worried about the already sky high cost of bait – made even worse by a federal cut in herring quota – and interstate and federal regulators are taking steps to protect endangered whales that will dramatically reduce the amount of gear fishermen can fish. As for State and Local, while the topics are much less high-profile, many of these bills impact how much say local people have over their own town and county governments. The Aging Caucus has been dealing with everything from how best to push for property tax relief to financial exploitation of our seniors. Additionally, I and other legislators from both parties have supported efforts to restore revenue sharing, expand the homestead exemption, and invest in the infrastructure our rural communities need.

And then there is Down East Correctional Facility. It could fill an entire town report on its own, however, I will simply say that our delegation has not given up on bringing the Bucks Harbor prison back, and putting as many of the workers at that facility back to work as we can. Whether we are successful remains to be seen, however we are extremely thankful for the support we have received from many of you reading this, as well as our colleagues in the Legislature who have helped fight for the prison the past five years.

TO THE CITIZENS OF WASHINGTON COUNTY

January 2019

I am humbled and grateful as I write this letter to you. While I ran unopposed during the election last November, I still am appreciative of each of the votes I received. I am grateful for your confidence in me to lead the Sheriff's Office for a second term.

We couldn't do the important work of serving all of our citizens without manpower. Chief Deputy Crabtree and I petitioned successfully for three additional deputies to be added to our roster in 2019. I would like to extend a sincere thanks to the budget committee for their very careful consideration and approval of our request.

For many years, the county has been divided into three patrol areas, which have been covered by the Sheriff's Office and the Maine State Police. The addition of the three new deputies will allow us to explore restructuring to four patrol areas which we hope will reduce response time in responding to an emergency and handling of complaints. Moreover, because the State Police are short-handed, they can no longer provide the assistance with certain cases like sexual assaults as they have in the past. The additional manpower will allow us to give these type of cases the serious attention they need.

Drug issues continue to be our biggest problem here in Washington County and across the State of Maine. The devastation of this epidemic is widespread and felt by all. We have continued the assignment of two full time deputies to the Maine Drug Enforcement Agency and are continuing to tackle this epidemic through concentrated investigations and enforcement.

A welcomed addition to the Sheriff's Office are two canines who became certified in narcotic detection, article search and tracking. Through continued trainings and certifications these K-9 units will provide valuable assistance in many areas of public safety.

Our Corrections Officers in the Washington County Jail, as well as our Emergency Communications Specialists in the Regional Communications Center, are busier than ever. Those jobs are incredibly tough, and I appreciate the tremendous effort from all of our department employees.

I am pleased to continue to serve the Citizens of Washington County.

Selectpeople's Report

The Select Board is pleased to provide the following information to the citizens of Machias outlining some of the things the Board has addressed over the last year.

This year saw the passing of former Selectman and Chairman of the Board Warren Gay. The Board of Selectpeople can never express our appreciation to Warren for his dedication to the Town of Machias and the surrounding community. He is greatly missed.

The Machias Valley Airport has seen significant continuing improvements over the last year, having received over \$4 million in federal and state funding. The new runway surface has been completed, along with lighting, road and apron work, and a new terminal. Voters approved a loan for the \$250,000 matching funds necessary to complete this project. Numerous businesses and citizens have pledged their financial support to offset these costs to the taxpayers, with the goal of raising \$200,000 in private contributions.

Machias voters adopted a Medical Marijuana Ordinance governing storefront operations in Machias. We have four shops licensed and operating under this ordinance, bringing in a minimum of \$12,000 in municipal license fees.

The board proposed, and the community approved an extensive, multi-parcel TIF district in an effort to spur building and development on Main Street and beyond. Machias Savings Bank, SCEC, IMK Properties LLC, and West Falls Holdings have already initiated almost \$5 million in new construction projects. It is expected that TIF revenue will be used for significant town wide infrastructure improvements.

A tower ordinance has been adopted by the voters that regulates all new tower construction in Machias to include cellular towers.

The proposed tax increase is a serious concern to the Selectpeople. Unfortunately, after extensive scrutiny the proposed budget is still an increase over the previous year. Most of this increase is due to reduced funding by the State of Maine for education. This year's proposed increase is necessary in order to continue to provide the appropriate educational opportunities for our youth.

The Selectpeople and the Budget Committee would like to recognize the School Committee for their hard work this year. The School Board voted to support the location of a temporary CTE site in Columbia as opposed to a site in Machias. The Select Board recognizes this difficult decision was not made lightly and appreciates their dedication to our children's education.

The Board of Selectpeople would like to thank the members of the Budget Committee as well, for their dedication and hard work during this budget process.

2019 Town Manager's Report

To the Residents of Machias:

The past year has seemed to fly by with so many ongoing projects and initiatives. The many projects underway have the potential to make some long-term significant and valuable changes to the community for future generations.

The proposed municipal budget for the next fiscal year has been presented to the Board of Selectpeople and the Budget Committee. This year has seen a decrease in the taxable municipal budget being presented to the voters. This is possible due to the use of \$40,000.00 additional Undesignated Fund dollars and a reduction in the Town's portion of the Washington County taxes caused by a reduction in the 2019 Machias state valuation. Unfortunately, the school's state funding was reduced causing a substantial increase for the school, most likely resulting in a tax increase of ½ mil. For example, a home valued at \$100,000.00 would have an increase of \$50.00 in taxes.

The Board of Selectpeople and the Planning Board continue to work through the new Medical Marijuana Ordinance and its application process. The Medical Marijuana Ordinance as adopted was a good starting point, but it has become apparent that some areas/issues need further clarification. The Town has successfully licensed four (4) Medical Marijuana Retail businesses in town as May 1, 2019. The Selectpeople must also begin the review process for the Adult Use Marijuana within Machias now that the State of Maine has released their guidelines. The Board is expected to begin workshops on these two issues in May 2019 and continue through August. I encourage all interested individuals to check for meeting dates and times on the town's website www.machiasme.org or by contacting the Machias Town Office to get on the email notification list.

The Ambulance Department has purchased two new I-PADS to replace the old Toughbook computers which have become outdated. A new power stretcher has been purchased for the ambulance. These units help with the lifting and transportation of patients while preventing many back injuries due to strained muscles. These stretchers have paid for themselves many times by the money saved from worker compensation premiums and claims.

The Machias and Marshfield fire departments applied for a grant to purchase an extractor washer and a dryer unit to clean turnout gear. This clothing is worn during firefighting operations and absorb many carcinogens from the smoke that are known cancer causing elements. This puts our firefighters at a much higher risk of developing cancer. The new equipment would allow the turnout gear to be efficiently washed and dried, removing the toxic particles. The volunteers have raised over \$6,000.00 toward this effort and the Machias residents have agreed to take the remaining \$15,000.00 from the Undesignated Fund Balance if the grant is unsuccessful. We expect to hear more by the end of June.

The Town completed Phase 1 of the Riverfront Resiliency Study and Report. This project was funded with a grant from Coastal Communities plus matching funds from Machias Savings Bank. The Town worked with the Maine Emergency Management Agency, Baker Designs, UMM GIS Lab, and Washington County Council of Governments to prepare and submit an application for a Federal Emergency Management Agency Pre-disaster Mitigation Grant to continue the important work of analyzing critical data on flood and storm impacts to our community. The goal is to address

the long-term negative impacts of rising ocean and flood waters. Part of the impacted area in a flood would be the existing boat ramp area. The Town has applied for a Small Harbor Improvement Grant to raise the ground elevations at the landing.

Our sewer construction project in the Elm Street/Grove Street area will be completed this summer. The Town will have one additional significant project to complete through the town's consent agreement with the Maine Department of Environmental Protection. That project consists of constructing a new pump station and possible holding tank to alleviate bypasses at the syphon. The Town continues to seek grant funds to offset costs to the Town's sewer users. We appreciate your continued patience while we finish the construction.

I wish to thank Olver & Associates that currently manage the operations at the Machias Wastewater Plant. The staff is very professional, and the Town continues to receive positive feedback from the various state agencies that inspect and regulate the plant.

The Town has applied for a Community Development Block Grant for the Downtown area. If the Town is funded through the program, the monies will be used to remove the curb cuts on Main Street, replace some of the sidewalks from the MSB Training Center to the old Main Street Discount lot, sidewalks from the (old) Office store to the corner of the Machias Hardware Store, and move the antique lighting in those areas to the inside of the sidewalks. This will create a flat walking surface for pedestrians, handicap accessible crosswalk areas, a straight curb for parking and plowing, and will protect the lights from being damaged by vehicles parking in the current cutout spots. The Town should learn if this application is successful around the end of May.

The Downtown Revitalization Committee has been vital in supporting the Town's efforts to continue improving the downtown area and waterfront for a walkable, pedestrian friendly community. It was recommended by the committee the Town should keep the same brick design but to utilize the new installation techniques that will help prevent shifting bricks. The Board of Selectpeople concurred that the sidewalk material shall remain the same. This will allow the new and old sections to blend as we complete separate construction phases. In addition, both the existing Downtown Plan and the Town's Comprehensive Plan are over 10 years old. It is important that both plans get updated during the next year as the municipality scores higher on grant applications with updated/adopted plans. The Downtown Committee will play an important role in identifying the future needs of the community. Thank you to everyone on this committee for your continued involvement and volunteerism. This group meets the second Friday of the month and has been active for over 15 years.

The Public Works Department building has a few projects that must be addressed in the next year. The existing metal roof is old and water is leaking through to the building's interior. The Town will be seeking quotes for a new roof this summer. The money for this project was included with the public works building and equipment loan last year, so no additional borrowing should be necessary for this project. The old furnace at the facility is beginning to cost more in annual repairs than a new purchase would be. The Town will obtain quotes for a replacement unit and then determine the best way to address the replacement. The unit is currently operating and the Town hopes the unit will last through one more winter. Time will tell. I would like to thank the Public Works Department for their dedicated work throughout this past non-stop winter of ice control. They did a fantastic job and we are lucky to have such a hardworking group.

A new compactor was installed at the Bay Area Transfer Station. The old unit failed last year. The project costs approximately \$41,000.00 but replaces a unit that has been in operation for over 30 years. The average life expectancy for this type of equipment is usually 20 years. The Town got the maximum use out of the old unit.

The Town also applied for a Land and Water Conservation Grant to rehabilitate the Salem Street recreational area consisting of the tennis courts, basketball court, and to add a playground area. While the grant application was accepted by the State, the terms of the town's property lease with IF & W is not acceptable to the federal grant guidelines. Therefore, the town is seeking additional funding sources for the rehabilitation. It is hoped that the all-purpose fenced court area, the basketball court, drainage improvements, and the playground construction can still be completed this summer.

The Machias Tele-business Center continues to offer modern office rental space. Please contact me at 255-6621 if you are looking for affordable and convenient office space for your business in Machias. I would be happy to give you a tour. The Town will also consider selling the building to a company creating employment opportunities or providing a community benefit.

I would like to express my appreciation to all Town employees their hard work and dedication to this community. Thank you.

MACHIAS AMBULANCE ANNUAL REPORT

Over the past year, Machias Ambulance has responded to approximately 900 to 1000 calls including emergency calls in our local communities, mutual aid to surrounding towns, as well as emergent and non-emergent transfers to higher level and specialty facilities.

All members continue to attend training throughout the year, as EMTs need 52 hours, AEMTs need 56 hours, and paramedics need 72 hours of education every 3 years to remain licensed through Maine EMS. This training is obtained through both in-house and off-site classes.

We have replaced our aging Toughbook computers with new iPads to ensure the ability to continue to comply with electronic run reporting and billing requirements.

We also replaced our last manual stretcher with an electronic stretcher to decrease the possibility of injuries from lifting and moving patients. Both ambulances now have these electronic stretchers.

Our members continue to provide coverage for the ambulance service 24/7 and extra coverage as needed for multiple calls and out of town transfers.

ASSESSOR'S REPORT FOR 2018 - 2019

This is my 25th annual report to the citizens of Machias.

The most recent analysis conducted by the Town and Maine Revenue Services compared assessed values to sale prices of residential properties in Machias showed that, on average, houses are assessed at 103% of market value. The prior year it was 101%. The year before that it was 103%. I think the safest conclusion from these figures is that real estate values are “stable.” The number of transactions analyzed did pick up 20%+, but six more sales does not make a trend.

Most home owning residents of Maine are eligible for a Homestead Exemption. Last year Machias homeowners saved up to \$477.40 on their property tax bill. You must apply to get it. You only need to apply once. Applications are available at the Town Office or online. Veterans who served in the Armed Forces of the United States during a federally recognized war time period who are 62 years old or older or totally disabled should determine if they are eligible for a Veteran’s Exemption. Spouses of deceased eligible veterans who have not remarried may also be eligible.

As a part-time contracted Assessor, I am available at the Town Office on selected Tuesdays. Town Office staff will take messages, make appointments and, if necessary, relay urgent information. Please feel free to contact me with any questions concerning the assessed value of property in Machias and other property tax related issues.

MACHIAS WASTEWATER TREATMENT FACILITY 2018-2019 ANNUAL REPORT

The Town of Machias' Wastewater Treatment Facility consists of eight miles of sewer collection system piping, one inverted siphon station, two pumping stations and a treatment facility with the capacity to treat an average of 900,000 gallons of wastewater per day. As we reflect on the past year, we want to personally thank the residents of the Town for all they have done, not only by supporting wastewater personnel in their jobs, but also by giving us the tools we need to do our job effectively. Through your actions, you have proven your commitment and respect for the environment. We would invite anyone interested in touring the facility to please call us at the Machias Treatment Facility, and we would gladly show you around, as well as explain how the process works.

2018 WASTEWATER TREATMENT FACILITY REVIEW

Process treatment summary:

94,180,000 gallons of wastewater was treated at the facility.

Effluent Biochemical Oxygen Demand (BOD) averaged 6.2 mg/l with a removal rate of 97%.

Effluent Total Suspended Solids (TSS) levels averaged 6.7 mg/l with a removal rate of 97%.

The licensed TSS and BOD monthly average limitations are 30 mg/l with a minimum removal rate of 85%.

Collection system progress:

A lot of work was completed within the collection system over the past year.

The wastewater crew, with the assistance of the Fire Department, cleaned and flushed the sewer lines and manholes on Stackpole Road, Allen Street, Broadway, North Street, Cooper Street, Center Street, Bruce Street and Lyon Street. This is very important to prevent sewer back up events.

We inspected cross-country lines from West Street to Water Street and Cooper Street to the treatment facility. The siphon station was cleaned and the three lines that run under the Machias River were flushed twice.

Wastewater Treatment Facility:

The wastewater staff spent a lot of time in 2018 completing housekeeping and maintenance to improve the overall appearance of the plant. This work included the following key items:

- All three clarifiers were drained and cleaned and pressure washed.
- The contact chamber was drained, cleaned and pressure washed.
- Replaced pump motor on composite sampler.
- Replaced faulty wasting valve.
- Replaced aeration blower #7.
- Replaced blower motor #2.
- Replaced return sludge pump #1.

- Had R.F. Jordan install a bypass valve and piping in CSO pumping station to enable us to periodically test the pumps.
- Replaced aeration diffusers in conditioning tank.
- Had PLC's programmed to allow outside contractor to remotely access PLC's to diagnose problems.
- Replaced pump and VFD in CSO pumping station due to storm electrical surge.

The Town of Machias Wastewater Staff is requesting your assistance to prevent blockages in sewage infrastructure, pipes and pump stations, resulting from improper disposal of consumer products. Examples of the consumer materials that can cause sewer blockages when disposed of in sewers include the following: - Baby/disinfecting wipes - Disposable toilet cleaning pads - Moist towelettes - Makeup removal pads - Disposable mop heads - Dental floss - Surface cleaning wipes – Candy wrappers – Towels. While many of these products are marketed as “flushable”, several studies, and the experience of utilities across the country, have shown that they do not break down after disposal like common toilet tissue. The synthetic fibers that make the wipes and other products strong and effective can cause them to form clumps that easily entangle in pumps without ripping. Sewage can back up behind these clogs, sometimes causing wastewater to discharge into homeowner basements. These products should be disposed of in the trash. The wastewater treatment industry is working with the manufacturers of these products to provide more accurate labeling, to define the term “flushable”, and to ensure that products are disposed of in a responsible way. Additional consumer items that may be labeled as “disposable”- such as diapers, feminine hygiene products, bladder control undergarments, plastic bags, and fabric cloths- should never be flushed. None of the products listed above should be disposed of in sewer or storm drain systems. Your cooperation in disposing of these wastes properly will protect not only your local surface waters but also the bottom line by reducing the need for cost increases to fund expanding maintenance requirements.

In closing, we would like to thank the Board of Selectmen, Town Manager and the Highway crew for helping to keep the wastewater infrastructure in top condition. Again, we would also like to thank the taxpayers for their support, because without your help, it would be extremely difficult to keep our Town and the environment the way we all expect it to be.

Superintendent of Schools Annual Report

To: The Machias Board of Selectmen, Machias School Committee and the Citizens of Machias:

It is with great pride that I report the state of the Machias School System in 2019. The Machias School Committee, administrators, teachers and support staff have worked diligently to ensure that all students that attend the Machias School System are provided with a high quality educational experience.

The Rose M. Gaffney School, under the leadership of Principal Joyce Fragale, continues to flourish. The highly motivated and talented staff at the Rose M. Gaffney School continues to be on the cutting edge of best educational practices. The Rose M. Gaffney staff members truly care about every child that enters their classrooms and are committed to meet the needs of all students.

The EDGE Afterschool program continues to provide high quality afterschool educational and recreational experiences for Rose M. Gaffney students. We certainly appreciate the dedication and commitment of the EDGE Program staff that have worked diligently to meet the needs of our students.

Machias Memorial High School is led by Principal Brian Leavitt. Mr. Leavitt is also the Director of Career and Technical Education and is firmly committed to meet the needs of all students that choose to attend Machias Memorial High School. MMHS has a very dedicated and talented teaching staff that care about each individual student that walks into their classrooms.

I also need to update Machias citizens regarding our campus facilities. During a special town meeting on April 23, 2019, the citizens of Machias approved paying the final payment on the Machias Memorial High School roof project a year early. It doesn't seem possible that 9 years have gone by since the project was completed. Also during the April 23rd town meeting the citizens approved the high school gym roof project at a cost of \$215,000.00. The gym roof replacement is long over due. It will be good to complete this project during the summer months.

During the current school year the Machias Administrators worked with several other school districts to secure grant funding to provide more Career and Technical Education funding for Western Washington County. The intent of the grant is to purchase and renovate a building, as well as, provide the necessary resources to provide four new programs for the 2020/2021 school year. The anticipated programs are Welding, Automotive Technology, Diesel Technology and Early Childhood Education.

The Machias School Department is supported by the AOS 96 central office team. I am very fortunate to have an extraordinary Special Education administrator. Mary Maker works tirelessly to ensure that our students receive the special services they need to be successful. The Machias School Department is also supported by longtime Machias educator, Mitchell Look. Mr. Look does an excellent job supporting our teachers in his role as Curriculum Coordinator and Federal Programs Manager. He has been a great addition to the AOS 96 central office staff.

The proposed 2019/2020 school budget for the Town of Machias is \$5,304,588.68. This budget reflects an increase in the tax commitment of \$74,936.18, which translates into just over a half mill increase in taxation. This increase is primarily due to salary and benefit increases. The Rose M. Gaffney School has one of the lowest tuition rates in the State and the high school tuition rate is very close to the state average which are true indicators of operating efficiently.

The Machias School Committee members will continue to provide the necessary resources for the success of all students. I look forward to working with Teresa Saddler, Richard Shaw, Joleen Nicely, Amanda Little and Carolyn Nadeau as they work hard to make the Machias School System the best it can be.

MACHIAS MEMORIAL HIGH SCHOOL PRINCIPAL'S - ANNUAL REPORT

To the Residents of Machias, the Machias Select Board, the Machias School Committee, and Superintendent Porter:

I would like to report to the community on several educational topics. This year I will highlight chronic absenteeism, student health, and Career & Technical Education.

Chronic absenteeism is defined as missing school, for any reason, in excess of 18 days per school year. The school sent information home to parents stressing the importance of good attendance and how it affects learning. We also have provided school-based interventions that have increased attendance rates for students

Our school struggles with student health issues. Vaping continues to be a problem not just in our school, but across our State. The school continues to educate our students, parents, and the community on the dangers of vaping. I have also reached out to the Maine Principal's Association for assistance and guidance related to this issue.

Mental health issues, specifically around childhood trauma, are prevalent in schools. Educators see the effects of trauma everyday in their classrooms, but generally lack the resources and skill set to handle them effectively. Teachers in Machias Schools are now receiving training and strategies to help students who have experienced trauma.

Coastal Washington CIT, the Career & Technical Education Center for this area, added a Health Occupations/CNA program of study in September. The Center will also be adding at least four new programs to its offerings: Early Childhood Education, Welding, Diesel Mechanics, and Automotive/Mechanical. These programs will compliment the existing programs - Culinary Arts, Building Trades, and Criminal Justice/Law Enforcement - for a total of eight programming options for students.

There are many great things happening in our school. Enrollment continues to increase, our teachers are effectively preparing our graduates for post-secondary school or career, and we have been able to retain our "small family atmosphere" at the school. Because of our small size, we are able to provide a customized education for students that meet their educational and personal needs.

The faculty and administration at Machias Memorial High School remains dedicated to providing the best learning experiences for all students.

REPORT OF THE DIRECTOR OF SPECIAL EDUCATION ANNUAL REPORT

To the Machias Board of Selectmen, Machias School Committee, and the Citizens of the Town of Machias:

The Machias Special Education Department continues to provide Special Education Services per Maine Unified Special Education Regulations. The Department is responsible for child find, ensuring students with special needs are evaluated, identified, and programs are created for them based on their level of needs in various skill areas. Students who transfer to the Machias School Department with an active IEP will continue to receive services based on their plan. We have had students transfer from other states as well as from other towns in Maine. The duty to provide services, whether they are academically or functionally based, occupational or speech/language therapy based, and/or direct/consultation services can be challenging depending on the level of need and scheduling per teacher and program.

We are in the second year of the audit by the Maine Department of Education. Per onsite and internal review of practices and files, we have been addressing Summary of Findings and making corrections as we met on each student throughout the 2018/2019 school year. We should be receiving a final notice of compliance prior to the start of the 2019/2020 school year.

The Ventures Gifted and Talented Program continues to identify students who are performing significantly above their same age peers. The identification process includes the screening of report cards, teacher referrals, assessments, and rating scales that look for characteristics of giftedness. Once students have been identified, a Professional Development Team establishes a differentiated program for each student.

Ventures students often take part in enrichment opportunities, which are provided for all students. This integration positively impacts our entire student body. The Ventures Program has continued to have a strong relationship with the University of Maine at Machias over the course of the 2018-2019 school year. UMM Professor Christopher Abbandonato has visited Rose M. Gaffney numerous times giving presentations on rockets, launch angles, physics, and static electricity. Our Ventures students are extremely fortunate to have these opportunities and have enjoyed them immensely. We owe many thanks to the UMM and Professor Abbandonato. In addition, Ventures Students visited the University of Maine at Machias **and** took part in the “Brain Bee” led by Professor Uriah Anderson in the Fall of 2018.

I would like to thank the Machias Selectmen and members of the Machias School Board. I appreciate the support I have received from Mr. Porter, the building administrators, and the staff members of Rose M. Gaffney and Machias Memorial High School. I would also like to thank the parents of our students for their continued support and participation in planning appropriate programming for their children.

Effective July 1, 2014, the Axiom Education & Training Center (AETC) began providing management and support to the Machias Adult and Community Education program. AETC is a 501 (c)(3) non-profit organization that provides Adult Education, Digital Literacy, Enrichment and Workforce Skills classes and training and is a designated STEM Hub through the Maine Math & Science Alliance for students 10-18 years old.

Effective July 1, 2015, the program was renamed **“Washington County Adult & Community Education”**. AETC is committed to expanding Adult Education and WorkReady skills training services to every town and territory in Washington County and recruiting and providing services to populations traditionally underserved by higher education. In this endeavor, expanding innovation and technology throughout Washington County and other regions plays a key role.

A state-of-the-art Adult Education Program has been developed that educates students in the latest technology through Distance-Learning Education (DLE) opportunities; offers community-requested courses, and utilizes technology to provide access to training through videoconferencing.

The instructor of the class may be on-or-off site depending on the course offered. The instructors may originate within Washington County or outside the region, depending on the curriculum offered. If the instructor presents the class via DLE (videoconference), the site may have a tutor or assistant to facilitate and assist the instructor and students. Classes are held at various times to accommodate the needs of the adult learners, with the goal of decreasing and eliminating the barriers to adult education and increasing the educational attainment of our workforce.

Axiom Education & Training Center Programs include the following:

- **Washington County Adult Education** -- Adult High School Diploma, HiSET Preparation and Testing, Adult Transitions Services, College Transitions, WorkReady, Workforce Development Training, Adult Literacy, Basic Skills, and English Language Learner.
- **WorkReady State Certification** - AETC is works with employers and offers a 60-hour WorkReady program.
- **Employers' Initiative Program (EIP)** - EIP provides customized technology and educational needs assessments, tailored technical assistance, digital literacy, as well as the education and workforce skills training.
- **Family Futures Downeast** - Partnering with Sunrise County Economic Council, Community Caring Collaborative, University of Maine at Machias, Washington County Community College, Downeast Collaborative Partners and numerous community, state and tribal agencies, to deliver a two-generational educational program for parents and their children in Washington County, Maine.
- **National Digital Equity Center (NDEC)** launched in the fall of 2018, and is committed is to closing the Digital Divide in Maine and across the United States. In addition to advocating for Affordable Broadband, Affordable Equipment and Public Computer Access, NDEC is focused on creating digitally literate citizens across Maine and beyond, providing communities with the expertise to mobilize broadband technologies through digital inclusion and literacy efforts.

Independent Auditor's Report

Report on the Financial Statements

We have audited the accompanying financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the Town of Machias, Maine as of and for the year ended June 30, 2018, and the related notes to the financial statements, which collectively comprise the Town's basic financial statements as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Other Matters

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the management's discussion, analysis, budgetary comparison information and pension, OPEB and information on pages 7 through 16 and 56 through 62 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Other Information

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise Town of Machias Maine's basic financial statements. The other supplementary information on Schedules 1 through 6 is presented for purposes of additional analysis and is not a required part of the basic financial statements. The schedule of expenditures of federal awards is presented for purposes of additional analysis as required by Title 2 U.S. *Code of Federal Regulations* (CFR) Part 200, *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards*, and is also not a required part of the basic financial statements. The reconciliation of audit adjustments to annual financial data submitted to Maine Education Financial System is presented as required by the laws of the State of Maine and is also not a required part of the basic financial statements.

The other supplementary information on Schedules 1 through 6, the schedule of expenditures of federal awards, and the reconciliation of audit adjustments to annual financial data submitted to Maine Education Financial System are the responsibility of management and were derived from and relate directly to the underlying accounting and other records used to prepare the basic financial statements. Such information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, Schedules 1 through 6, the schedule of expenditures of federal awards, and the reconciliation of audit adjustments to annual financial data submitted to Maine Education Financial System are fairly stated in all material respects in relation to the basic financial statements as a whole.

Other Reporting Required by *Government Auditing Standards*

In accordance with *Government Auditing Standards*, we have also issued our report dated January 9, 2019, on our consideration of the Town of Machias, Maine's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Town of Machias, Maine's internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the Town of Machias, Maine's internal control over financial reporting and compliance.

ARTICLE 13: (Written ballot required) Shall the Town raise and appropriate **\$502,586.11** in additional local funds, which exceeds the State's Essential Programs and Services allocation model by **\$502,586.11** as required to fund the budget recommended by the school committee. Machias School Board, Budget Committee and Board of Selectpeople recommend.

The school committee **recommends \$502,586.11** for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services funding model by \$502,586.11: The Machias School Department budget is over the Essential Programs and Services model in student to teacher ratios in the high school, school administration, guidance, library, system administration, maintenance and clerical costs. In addition, the Essential Programs and Services model does not fully fund co-curricular activities and the model has not been fully funded by the State.

Explanation: The additional local funds are those locally raised funds over and above the Town's local contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act that will help achieve the Town budget for educational programs.

ARTICLE 14: Shall the Town authorize the school committee to expend **\$5,304,588.68** for the fiscal year beginning July 1, 2019 and ending June 30, 2020 from the Town's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, Section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools. Machias School Board, Budget Committee and Board of Selectpeople recommend.

ARTICLE 15: Shall the Town be authorized to expend such other sums as may be received from federal or state grants or programs or other sources during the fiscal year for school purposes provided that such grants, programs or other sources do not require the expenditure of other funds not previously appropriated. Machias School Board, Budget Committee and Board of Selectpeople recommend.

ARTICLE 16: Shall the Town appropriate **\$20,000.00** for adult education and raise **\$20,000.00** as local share; with authorization to expend any additional, incidental, or miscellaneous receipts in the interest and for the well-being of the adult education program. Machias School Board, Budget Committee and Board of Selectpeople recommend.

ARTICLE 17: Shall the Town appropriate **\$10,000.00** for adult basic education and raise **\$10,000.00** as local share; with authorization to expend any additional, incidental, or miscellaneous receipts in the interest and for the well-being of the adult basic education program. Machias School Board, Budget Committee and Board of Selectpeople recommend.

ARTICLE 18: Shall the Town to vote and authorize Selectpeople to issue notes not to exceed a period of five years in the name of the Town of Machias for the purpose of purchasing a school bus for the Machias School Department in an amount not to exceed \$89,300.00 and to be paid back through the Machias School Budget.

ARTICLE 19: In addition to the amounts appropriated under Article 2 through Article 18, shall the Town of Machias appropriate \$225,000.00 from the Machias School Department's undesignated fund balance to off set over all budget for the Machias School Department.
